Each bid must be accompanied by proof of Contractor's DPMC classification status.

For projects with NJSDA funding the New Jersey Schools Development Authority NJSDA prequalification process requires that each bid must be accompanied by proof of Contractor's DPMC classification status with NJSDA's School Finance and Construction Program.

Bidders are required to comply with requirements of N.J.S.A. 10:5-1 et seq., "The Law Against Discrimination," and affirmative action, N.J.S.A. 10:5-31 et seq. and N.J.AC. 17:27-1 et seq.
